

# What the "FISH" are you talking about?

#### ... and what has it got to do with Sales, Marketing or even Branding?

**Everything!** Whether you love eating fish, or fancy fishing as a hobby or not, there are many similarities we could definitely draw upon to grow our businesses by leveraging on the art of a good catch. Often we hear analogies that describe sales people as hunters. But in actuality, selling is less about pointing a weapon at a single visible target, but more about finding and knowing the targeted customers well enough and wining their hearts with the right proposition (the right bait as in fishing). Like fishing, wining the hearts of the customer requires many of the same activities as landing a big catch.

You see, customers are a lot like fish, waiting to be hooked. So wouldn't it make a lot more sense to know exactly what would they love to bite on? We have to have something the fish will bite on, we have to have something they want today. If we don't have the right bait, they will not bite and we will not catch any fish. This is not good and only ends with us having to go home with only a fish story about the one that got away. Similarly in business, we all want more business, more sales yet many companies are unclear about their target markets. To reel in the catch, meaning wining the hearts of our customers, we must first begin by having the right bait, i.e.: the right value proposition in place. You have to present something they will want to have, desire to have or something they need to have. Something they will buy. Otherwise, we will end up running around town trying to sell to everyone, and we end up with no catch sadly.

Then the next thing you'll need to know is, is to find the right place to fish. A place that actually has fish that we can catch. It really isn't that much different in business either? Finding the right place to fish is akin to finding a place that has prospects that you can meet, prospects that fit what you are looking for, prospects that you can catch. So, whether fishing, or prospecting, you have to find the right place.

But we must be careful for even if we know the great places to fish and yet we do not fish there, we defeat the purpose. What happens if instead of going to the best places, we go to the places easiest to get to, the places closest, or the places we like to hang out best? The answer is obvious, we do not catch all the fish we could.

Think about it, if we know the great places to prospect and yet we do not prospect there, instead we elect to go to the places that are easiest to get to, the places closest to us, or the places we and our buddies like to hang out at – then our sales truly suffers.

The third thing in fishing, we have to have is the right technique; we have to know how to cast the pole, play the fish when they are biting and hook the fish when the time is right. Remember, we can have the right spot and right bait, but our inability to fish will still send us home empty handed. Likewise, in growing our sales, we also have to have the right technique, we have to know how to build relationships, create opportunities and build proposals. Too many times we know the right spot, we have the right product, but we are not very good at securing it – thus we talk about the one that got away.

In fishing if we do not listen and learn and practice the things we are taught about being a great fisherman, we will never be great. If we don't learn how to play the fish, how to hook them, how to reel them in, then we get no fish. It's the same in business.

One final point, in fishing we have to know how to bring the fish in, how to keep them hooked and how to reel in the fish and put him in the cooler. In growing our sales, the final ingredient we have to have is to know how to attract the customer, keep them hooked and close the deal, "show me the money". If we cannot reel in the fish successfully, it doesn't matter if we know the right places, use the right bait, or have the best equipment, or play the fish, if the fish does not end up in our cooler, then we are unsuccessful.

It is not any different in business, we can be the greatest at networking, the one who has the best looking busness cards and materials, the one who know how to meet with the people and get all the information, who knows how to put the best proposal in the world together, if we do not close and get a check, we are unsuccessful.

Unfortunately most businesses today have way too many fish left un-catched. I called these as leakages and missed opportunities. The businesses that got away!

For that reason, I have developed a methodology called F.I.S.H.I.N.G to help businesses plugged their leaks once and for all and have a step by step plan to reel in more fish in their business. It's a methodology for business growth, for more sales, effective marketing & strategic branding. 

#### DRINKING WATER TESTING

The quality of drinking water is a powerful environment determinant of health. Assurance of drinking water safety is a foundation for the prevention and control of waterborne diseases. We provide accredited drinking water testing services in compliance with the Ministry of Health (MOH) 25th & 25th A Schedule and the World Health Organization (WHO) drinking water guidelines.



#### **SWAB & AIR TESTING**

Microorganisms are ever present in all food handling environment. These microorganisms can be classified into two unique groups as transient and resident. If contamination levels are too high or sanitation procedures are insufficient and inadequate, transient microorganisms may rapidly grow and multiply until reaching or becoming resisdent. To detect such microorganisms, surface swab will be performed on employee's hand, utensils, benches or any other areas probably in contact with food during production processes. Apart from the surface swab, air monitoring using the bio-aerosol impactor or sedimentation method are also administered to monitor microorganisms such as total bacteria, mould or yeast.



#### MICROBIOLOGICAL TESTING

Without proper sanitation, harmful bacteria can easily contaminate our food. To ensure your food product are safe we conduct microbiological testing according to methods such as USP, BP, FDA-BAM, AOAC, APHA, AS/NZS, especially for products such as medicine, traditional herbs cosmetics, food supplements, canned food, general food, feed, water, waste water and medical devices.



#### SHELF LIFE STUDY - FROZEN & NON FROZEN FOOD

Shelf life is the length of time that food, beverages, medicines, chemical and many other perishable products are given before they are considered unsuitable for sale, use or consumption. We adopt the National Pharmaceutical Control Bureau (BPFK) methodology to conduct the accelerated shelf life testing. The shelf life of all frozen food can be defined as the time period in which the frozen food is safe for consumption and has an acceptable quality to consumers. we are capable to determine the shelf life study or any type of frozen food store under - 18°C (0°F) or less.

#### Working at Height – Are you safe?

Because of the risk of a fall and potential for serious injury when working at height, measures should be taken to protect against them in the early stages of any project involving work at height. In an individual risk assessment those measures should be selected according to their position in the risk hierarchy: Firstly organizing an alternative working sequence which avoids work at a high elevation; secondly selecting an appropriate technical measure, preferably collective protection and thirdly selecting appropriate personal fall protection.

#### Responsibilities under the FMA 1967 and OSH Act 1994

To prevent falls relevant sections of the Act and Regulations, namely:

- Occupational Safety and Health Act, 1994
- Section 15(2)(c):"....Information, instruction, training and supervision..."
- Section 17: General duties of employers and self-employed persons to persons other than their employees;
- Section 20: General duties of manufacturers, etc. as regards plant for use at work
- Section 24: General duties of employees at work; and Factories and Machinery Act, 1967
- Factories and Machinery (Safety, Health and Welfare) Regulations, 1970, Regulation 12: Working at a height;
- Factories and Machinery (Building Operations and Works of Engineering Construction) (Safety) Regulations, 1986

#### Avoid working at height

Out of the number of solutions which are generally possible, a selection should be made which provides the lowest risk. To achieve this, the first step should be an identification of existing hazards, when coming to practical work situations. After the decision is made on which work is to be done at height, a safe location and environment needs to be provided. Furthermore, it is essential that the work is done by a qualified and competent employee.

#### Competentancy

Principals, persons in control of the workplace and employers shall take all practicable steps to ensure that the permanently installed access equipment is only used within its design criteria by competent persons. Capability of identifying existing and predictable hazards in the surroundings or working condition which are unsanitary, hazardous, or dangerous to employees and has authorisation to take prompt corrective measures to eliminate them.

#### Personal fall protection

If a working sequence at an elevated position cannot be done at or from the ground level and the provision of effective barriers such as guard rails at this position has to be excluded for reasons pertaining to the work sequence itself and intercepting devices such as safety nets are not appropriate because of the particularities of the project, personal fall protection would need to be used. However, the effect of PPE depends on the competence of the employee, his sense of responsibility and his physical and mental fitness.
