#### PPE Product:

Portwest Glowtex Hi-Vis Vest Style G470, constructed from a 124g/m<sup>2</sup> warp knitted polyester fabric in yellow or orange. The garment features two bands of sewn on retro-reflective tape encircling the torso with over the shoulder bands. Additionally, a 5 cm band of photo luminescent material is sewn on at the chest and back, and a 4.5 cm band of photo luminescent material is sewn on immediately above the upper horizontal retro-reflective band. The garment is available in five nominal sizes the smallest being S/M.

When examined the PPE satisfied the relevant requirements in the harmonized standard,





