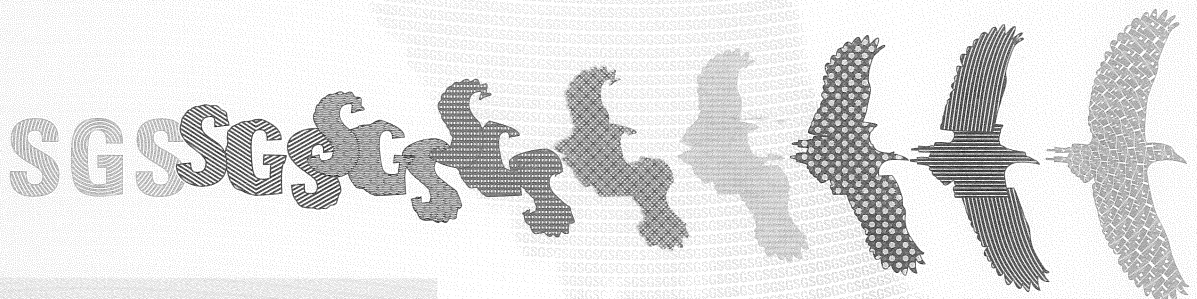

Respirex (logo) GTL gas-tight suit manufactured from a yellow barrier laminate on reinforced non-woven fabric (reference RXL159) with welded & taped seams and twin exhalation valves. The suit has a semi-rigid laminated visor, integral booties with plain outer legs, a long gas-tight zipper closure on the front right hand side of the suit which is covered by an outer flap with a hook & loop closure. The suit is available in five nominal sizes and various design options for sleeve terminations and air systems : product code: GTL159V06S\*\*L09Z15A\*\*. Where \*\* is the relevant option code.

This suit must be used with an EN 137 compliant self-contained open-circuit breathing apparatus worn inside the suit & EN 345-2 Type FPA (or equivalent) safety boots, plus protective headwear and over-gloves as appropriate.

It is certified that the manufacturer's technical file and the above mentioned PPE have been assessed and found to be in accordance with the requirements of Council Directive 89/686/EEC. When examined the PPE satisfied the requirements in the relevant harmonized standard:
